New Business: CCRC went over the contract for Cornwell, from Long Lake to Haskel Lake road. They would do four inches of asphalt overlay, including trees and drainage. Scherrer made a motion to accept the Clare County Road commission contract. Ecklin second it. All in favor. Motion carried. The CCRC is also going to take some of the brush back to widen woods road, so a truck can get down it. Next brine is July 9th. William Faber will be running for drain commissioner. David Hoefling gave update on airport. Someone wants to do a flight training school there. Also have sate funded grant to update the hangers. Someone made a complaint about all the Airbnb coming to the township. The Board will look into what other townships are doing for that. Also had a complaint about the campsite that will be on four lots, one campsite per lot. He has filed stating where the septic is going to go. There will not be any campers with bathrooms allowed and there will be porta potties on each lot. We were asked about MMR if anything has come about. Nothing has changed, but their response times are getting better. Clerk announced the election inspectors for August Election, Shelly Shultz, Eric Echelbarger, Lanette Tagliamonte.
