Also has a complaint in elbow lake about a neighbor who is lining his property with junk and is blaring the radio pointing at the other person's house. A campground is being opened and some people are not happy about it. Also, there are airbnb's opening and people are worried about the safety and with it being a private lake. But we do not have any ordinances stating you cannot Airbnb your house. Talked about getting grey plastic tables to replace the heavy wooden tables we have now. Along with getting gutters for by the door.
